I agree and understand that, on behalf of myself, my personal representatives and my heirs, I am relinquishing any and all rights I now have or may have in the future to sue OCLEAC or any of its members, organizers, volunteers, or officers for any and all injury, damage, or death I may suffer arising from riding as a driver or passenger in this event to include the use of any equipment provided, and including claims based on OCLEAC negligence.
